J.E.S.I Management Solutions Pty Ltd (ACN 159 033 179) trading as SafetyIQ (**SafetyIQ, we, us and our**) is committed to protecting the privacy of individuals and their personal information and complies with the *Privacy Act 1988* (Cth) (**Privacy Act**).

Please read this carefully as it will have important consequences for you in relation to the collection, use and disclosure of your personal information you provide to SafetyIQ.

You understand that:

1. SafetyIQ is the party who is collecting your personal information and can be contacted at corporateservices@safetyiq.com or alternatively you can write to us Level 10, 15 Green Square Close, Fortitude Valley Qld 4006.
2. SAFETYIQ will collect your personal information directly from you. In certain circumstances, SAFETYIQ may be required to collect personal information from third parties, including from third-party applications that are integrated into SAFETYIQ's application software depending on the products and services you use.
3. The purpose of SAFETYIQ collecting your personal information is to:
 - (a) verify your identity and occupational details, including your position and responsibilities;
 - (b) provide you with the products and services in SAFETYIQ's software application;
 - (c) create your account with SAFETYIQ and provide you with access to SAFETYIQ's software application and use of its features;
 - (d) process any payments for products and services provided by SAFETYIQ;
 - (e) provide customer service functions, including handling user enquiries or complaints and providing you with information in relation to your enquiry, including without limitation, contacting you regarding any enquiries submitted via our social media pages or SAFETYIQ's software application;
 - (f) process your feedback for the improvement of our products and services;
 - (g) when applicable, identify your location to facilitate the safety of your working environment; and
 - (h) when applicable, facilitate the provision of medical assistance in the event of any emergency identified through your use of location services in SAFETYIQ's software application, including by notifying your employer and emergency contacts,and you acknowledge and agree to your personal information being collected and used for, and in connection with, these purposes and any other purpose described in our Privacy Policy.
4. If we do not collect this personal information in connection with the purposes in paragraph 3, then SAFETYIQ will be unable to:
 - (a) verify your identity and occupational details;
 - (b) grant you access to SAFETYIQ's software application or facilitate full use of the features of the application;
 - (c) provide you with customer services, process your enquiry or complaint, or supply you with information; and
 - (d) contact your employer or emergency services to provide you with medical treatment.
5. Your personal information may be disclosed to the following classes of people and organisations in connection with the purposes in paragraph 3:
 - (a) SAFETYIQ, its personnel and related entities;
 - (b) third party service providers including without limitation marketing service providers, IT service providers, contractors and sales consultants and other parties, who assist us in providing our products and services to you;
 - (c) third parties connected with the sales and after sales process including, ecommerce services and financial institutions, namely Stripe; and
 - (d) any other organisation as expressly covered in our Privacy Policy.
6. It is possible that some of the information collected via your new account may be disclosed to SAFETYIQ's service providers outside of Australia. You **consent** to your information being disclosed to a destination outside Australia for this purpose, including but not limited to **the United States of America** and you understand and acknowledge that Australian Privacy Principle 8.1 will not apply to such disclosures of your personal information.
